Mile Stones of RCAPS



The Ritsumeikan Trust established the Ritsumeikan Center for Asia Pacific Studies (RCAPS) in July 1996, as part of the preparations for the opening of the Ritsumeikan Asia Pacific University. The aim of the center was to promote advanced studies in the Asia Pacific Area. This was to be done in association with the fifteen existing institutes and centers at Ritsumeikan University campuses in Kyoto and Kusatsu cities. Thus RCAPS founding precedes the establishment of APU in Beppu.

In October 1996, an international symposium titled "Prosperity and Coexistence of Asia: The Role of Japan and Korea" was conducted at Seoul Press Center in Korea, under the joint auspices of Ritsumeikan University, Kyung Hee University, and the Kansai Association of Cooperate Executives.

An International Conference on "New Dimensions in Asia Pacific Studies" was held in Beppu in June 1997 under the sponsorship of Ritsumeikan University, in association with Beppu City and Oita Prefecture.

Professor SAKAMOTO Kazuichi, then President designate of Ritsumeikan Asia Pacific University presented a paper on "A New Dimension of Asia-Pacific Studies" which outlined the philosophy for establishing APU and RCAPS direction within APU.

Ritsumeikan Center for Asia Pacific Studies (RCAPS) launched the publishing of the first volume of the Ritsumeikan Journal of Asia Pacific Studies (RJAPS) in August 1998. Professor ONAMI Masateru President of the Ritsumeikan Trust and Ritsumeikan University inaugurated the Journal's launch. Ten academics contributed articles to the first volume, while four international institutions sent congratulatory messages.

RCAPS address in the founding year used to be the address of the Office of Planning of the APU at Ritsumeikan University. Of the 24 academics associated with RCAPS, the majority of them became the academic staff of APU when it was established. Professor SAKAMOTO Kazuichi was the Director, while Professor HOTTA Makitaro served as the Secretary-General

On January 2000, RCAPS finally moved from Kyoto to its present premises at APU. By that time, four issues of the RJAPS had been published.

In the first year of APU's opening, the Center supported a number of researchers with grants. It also organized two international symposiums on Asia Pacific Studies and Asia Pacific Management education. The Center also organized regular talks by visiting academics.

In 2001, the Center drew up a three-year plan to promote research by members of APU academic community by giving seminars on a fortnightly basis. It has also planned to invite distinguished scholars from other universities. Two symposiums that will bring together both APU academics and other scholars have been launched. Many of these activities are intended to lead to the dissemination of research in the form of articles in RJAPS or monographs by the Center. In order to promote book length research and edited papers, the Center has launched the Asia Pacific Research Monograph series.

1996年7月、立命館学園は立命館アジア太平洋大学の開学に先立ち立命館アジア太平洋研究センターを設立。センターはアジア太平洋地域において高度な研究を発展させることを目的とし、立命館大学の衣笠・びわこ草津両キャンパスにおける15の既存研究施設と連携してAPU設立に先駆けて創設された。

1996年10月、「アジアの繁栄と共存―日本と韓国の役割」と題した国際シンポジウムが、立命館大学、慶熙大学校、および関西経済同友会の共催のもと、韓国のソウル・プレス・センターにおいて開催された。

1997年6月、「アジア太平洋学のエポック」をテーマとするセンター主催の国際シンポジウムが、別府市および大分県の後援のもと開催された。当時立命館アジア太平洋大学学長予定者であった坂本和一教授より、「アジア太平洋学の可能性」と題した講演の中でAPUの設立理念とAPU内におけるセンターの方向性について概略が報告された。

1998年8月、センターは立命館アジア太平洋研究ジャーナル 第1号を発行した。立命館総長および立命館大学学長の大南正 瑛教授によりジャーナル創刊号の巻頭が飾られ、10人の教員が 第1号に寄稿、海外からは4つの機関から祝辞が寄せられた。 創設年にはセンターは立命館大学内のAPU開設事務局内にお かれた。当時センターには研究員(教員)として在籍していた 24名のほとんどは、APU設立時、教員としてAPUに移籍した。 坂本和一教授がセンター長、堀田牧太郎教授が事務局長を務めた。 2000年1月、センターは京都から現在のAPU所在地へ移転し た。移転時には既に立命館アジア太平洋研究ジャーナルは4号 を発行した。

APU開学1年目、センターは多くの研究者の研究助成を行な うとともに、アジア太平洋学、およびマネジメント教育に関す る二つの国際シンポジウムを企画・開催した。さらに、客員教 授による講演会等も開催された。

2001年、センターは3ヵ年計画を打ち出し、APU教員による研究推進のため、隔週でAPU教員によるセミナーを開催している。また、他大学からの優れた研究者を招聘するセミナーも企画している。APU教員と他大学教員による2つのシンポジウムの開催も企画された。これらの活動の成果は、センター紀要「Ritsumeikan Journal of Asia Pacific Studies」または、モノグラフ形式で発表されることとなっている。また、長編の研究論文や編集論文出版を推進するため、センターはアジア太平洋研究論文(モノグラフ)シリーズを企画している。

International Symposium

Research and Education through IT

July 28, 2001 at Student Hall, APU

An international symposium was held on July 28th at APU Student Hall under the theme of "Creation of Research and Education through IT." The symposium, featuring a panel of 22 participants including 7 from outside the university, was attended by the faculty and administrative staff of both Ritsumeikan University and APU, APU students and the general public.

The symposium began with addresses by APU President SAKAMOTO Kazuichi and Prof. A. Mani, The President spoke of the significance of IT in university education and research.

Prof. Mani presented the importance of development, education and research in the Asia-Pacific region, stating that the wide spread usage of IT in education and research would contribute to the region by enabling wider and freer access to information.

Part I of the symposium, held under the sub-theme "Research and Information Networks through IT," was opened with keynote reports by Prof. Monte Cassim, Director of the Center for Global Education and Research of Ritsumeikan University, and Mr. HAYASHI Kaoru, Deputy Director General of the Research Institute for Development and Finance of Japan Bank for International Cooperation.

Prof. Cassim spoke of creating a "Knowledge Bank" and the challenges to be overcome for its management. He stressed the importance of the role of universities and other higher educational institutions in the global IT revolution and the need for adaptation to changes in educational and research environments. Mr. HAYASHI explained, based on his extensive experience, the importance of constructing an intellectual network for accumulating knowledge and promoting its shared use in an advanced information technology society, as well as the technology necessary to accomplish this. He emphasized in particular the promotion of a "Global Development Network (GDN)." These two keynote reports were followed by discussions on various subjects, ranging from university participation in the "Knowledge Bank" and GDN construction to intellectual property rights concerning the network and accumulated knowledge.

In part II of the symposium, held under the sub-theme Case Reports on the Research and Education through IT," keynote reports were presented mainly about actual cases of IT-aided education. Associate Prof. NAGAMATSU Toshifumi presented basic concepts of E-learning and its effects on education and reported on the changing roles of teachers and students. He also gave a video presentation of a case study of an educational project using WebCT, a software program developed at the

University of British Columbia to support course preparation over the network, which is now considered the de facto standard for institutions in North America. Prof. UNETANI Takako and Lecturer UMEDA Chisako then introduced a Japanese language course using WebCT, demonstrating the possibility of studying a foreign language, mainly daily conversation, over the network.



Prof. Richard Berwick presented a specific case of English language education using WebCT, demonstrating the use of image software to assist with conceptual understanding. Lecturer Gordon Gamlin demonstrated a WebCT-aided course "Media English" that he had actually taught, which reinforced the importance of student collaboration. Finally, Lecturer HARA Tomoaki of Oita Prefectural College of Arts and Culture reported on a case of collaborative learning over the Internet.

The keynote reports of part II were followed by a plenary session on IT in education. Many topics were discussed, including problems related to global network infrastructure, such as the so-called "digital divide," and the need for inter-university or university-business collaborations, in connection with the discussions of Part I.

As discussed in the symposium, it is believed that the network and content development in an advanced information technology society will reinforce the importance of university-community and international interuniversity collaborations. To further develop "Asia Pacific Studies", one of APU's objectives, IT-based collaboration is an important issue. The application of IT in a variety of specific projects and programs --- such as in the development of research and educational standards of APU Graduate School, currently under way toward its target opening in 2003, and joint development and use of research and educational content through APU-Ritsumeikan collaboration --- is expected to result in higher educational standards of the Ritsumeikan Trust.

APU国際学術シンポジウム 「ITを活用した研究・教育の構築」

2001年7月28日 APUスチューデントホール

2001年7月28日、学内外より17名のパネリストを迎え、「IT時代における研究と教育の構築」をテーマとするシンポジウムが開催された。

開催にあたり、坂本和一学長が、ITを大学教育・研究へ活用していくことへの意義について挨拶を行った。続いてアジア太平洋研究センター長のA. Mani,教授がアジア太平洋地域の発展と教育・研究の重要性、そしてITが教育・研究へ浸透し、知識が国境を越え開放的に活用されることで、アジア太平洋地域へ貢献すると挨拶を行った。

第1部においては「ITを用いた研究ネットワーク構築」について国際協力 銀行開発金融研究所林薫次長、立命館大学政策科学部教授/研究機構長 M.Cassim教授による基調報告が行なわれた。M.Cassim教授は、地球規 模においてIT革命が進行し、その過程で大学を含む高等教育機関の役割の重要 性、そして教育・研究環境変化への対応の必要性を具体的に示し、"Knowledge Bank"の構築とその管理のための課題について報告を行った。林次長は高 度情報社会における知識の蓄積やその共有を牽引する知的ネットワーク構築 の重要性またそのための手法を豊富な経験に基づいて、説明し、とくに "GDN(Global Development Network)"の推進について報告を行った。

この二つの基調報告をもとにして、大学としての'GDN'や "Knowledge Bank"への関わり方、ネットワークや蓄積された知識に関する知的財産権などさまざまな問題などについて討論が行なわれた。

第二部では、「ITを用いた教育・研究の事例」についてAPU教員を中心に 基調報告が行なわれた。

永松利文助教授はE-learningの基本的概念とそれがもたらす教育効果と、教員や学生の役割の変化について報告を行った。そして、ブリティッシュ・コロンビア大学で開発され、北米を中心にネットワーク上でのコース作成支援ソフトウェアのデファクトスタンダードとなっているWebCTを用いた教育の事例がビデオ映像により紹介された。

続いて宇根谷孝子教授と梅田千砂子講師が同じく日本語教育のWebCTを

使ったコースを紹介し、日常会話を中心にネットワーク上で学習ができる事例を報告した。R. Berwick教授は英語教育におけるWebCTの具体的事例として概念的理解を助けるための映像アプリケーションの効果についてデモンストレーションを行った。さらにG. Gamlin講師が「メディア英語」の授業で実際に使用した、WebCTのコースについてデモンストレーションを行った。ここでは学生と協同でコースを開発することの意義について報告された。

最後に大分県立芸術文化短期大学の原知章講師より、インターネットを用いたネットワーク上での協調学習の事例について報告された。

基調報告後、ITを用いた教育の進め方に関する討論が行なわれ、いわゆる「ディジタル・ディバイド」による地球規模でのネットワーク・インフラの問題や第1部と関連して大学間或いは大学と民間機関との連携の必要性など、多くの問題が議論された。

ここで議論されたように、高度情報社会における大学はネットワークやコンテンツの発展により、社会とのつながりや国境を越えた大学間連携が重要になってくると思われる。APUが目指すアジア太平洋学の構築においても、ITとの連携は重要な課題である。

さらに2003年を目途に進められているAPU大学院での研究・教育の高度 化、またAPUと立命館大学との連携による研究・教育コンテンツの協同開発 や利用によるシナージー効果など、今後具体的なプログラムをITを活用して 行えば、立命館学園全体の教学の高度化にもつながると考えられる。

今回のシンポジウムは、今後の研究・教育におけるIT活用に向けた有意義な討論が行なわれたといえる。

シンポジウムの成果は、立命館アジア太平洋研究センター紀要「Ritsumeikan Journal of Asia Pacific Studies」にまとめる予定である。

After the United Nations Conference of the Human Environment in Stockholm in 1972, and the United Nations Conference on Environment and Development (also known as the Earth Summit) in 1992 were held, international disinterested action has been conducted in cooperation with nations for global environmental issues such as global warming. Johannesburg 2002: The World Summit on Sustainable Development (Rio+10), a summit gathering to assess the global changes in the decade following the Earth Summit in 1992 will be held. This symposium was organized as a preparatory activity for the world summit. With its main guest, the Honorable Maurice F. Strong, President of the Council, University for Peace, and Under-Secretary General of the United Nations, an eminent leader of global environmental issues for over thirty years, the symposium analyzed the current status of the urban environment in the Asia Pacific region and discussed the future of sustainable development. ■Cambodia's Prime Minister Visits APU

Cambodia's Prime Minister H.E. Mr. Hun Sen, visited the APU campus on Sunday 10th June 2001. It was a brief visit lasting about an hour to know of the achievements made by the university.

The Oita Prefecture Government assisted Prime Minister Hun Sen's visit to the campus. APU President SAKAMOTO Kazuichi, Vice President JIDO Yuji Dean of Academic Affairs Prof. NAKAGAMI Kenichi and RCAPS Director Prof. A. Mani met with Prime Minister Hun Sen and the team of experts he led. President Sakamoto explained the developments within APU and introduced the APU Professors.

Prime Minister Hun Sen also met with the single Cambodian student studying at APU. It is hoped that His Excellency's visit will encourage more Cambodian students to join and benefit from the education offered at APU. From the Fall Semester, we now have 4 Cambodian students.

RCAPS hopes to organize regular seminars in the near future on the countries in Indo-China to promote a better understanding of and academic interest in Cambodia, Laos and Vietnam.

Japan Association for Asian Studies at APU

The conference for Western Japan members of the Japan Association for Asia Studies was held on campus on Saturday, June 23, 2001. More than 120 attendees participated in 5 sessions in total, despite the bad weather, and it was indeed an unexpectedly fortunate miscalculation on the side of the sponsor and executive members in charge of the conference that there were so many participants.

In the conference, 25 participants made their presentations in various diversified fields including problems in China, Taiwan, and issues facing Asia in general, history, literature. In addition, Dr. KOJIMA Tomoyuki, Professor, Faculty of Policy Management, Keio University, and also a former chairperson of the Board of Trustees of the Association, gave a commemorative lecture titled "East Asia and Japan: from the viewpoint of regional collaboration" lasting one hour after lunch. Nearly 300 people including not only the members but also Beppu citizens and students participated in the lecture. The people concerned believe this was a good example of APU interacting with the local community.

One more thing to note is that the students, mainly 2nd year students, played active roles in the conference. Many participants evaluated this highly and commented that it was not like the conference held in a newly opened university.

Professor Ezra Vogel delivers a Lecture

Dr. Ezra Vogel, Visiting Professor of APU, Professor Emeritus of Harvard University visited APU, and delivered a lecture at a research meeting sponsored by RCAPS. The lecture was given under the theme U.S. — China — Japan Relations Since World War $\rm II$. Dr. Vogel reported changes in relations between the U.S. and Japan focusing on historical turning points in China since the World War $\rm II$. After his report, all in attendance enjoyed a lively discussion which was still continued over lunch Dr. Vogel also gave a special lecture for APU students on the previous day on the same theme, and some 60 students from 17 countries and regions attended the lecture. Students who attended the lecture seemed to be enlightened by Dr. Vogel's detailed analysis on the role of these three countries. This special lecture must have been a meaningful and memorable experience for the students.

カンボジア首相来学

カンボジア首相Hun Sen氏が2001年6月10日APUを訪問された。APUの現状について視察する約1時間の短い訪問であったが、有意義な機会であった。

今回は大分県の計らいで首相の訪問が可能となっ



た。坂本学長、慈道副学長、仲上教学部長、およびMANI立命館アジア太 平洋研究センター所長が首相とその関係者と懇談、坂本学長が首相にAPU の現状について説明し、APU教員を紹介した。


また首相はAPU在学中のカンボジア人学生とも懇談した。首相の訪問に勇気付けられ、より多くのカンボジア人学生がAPUへ入学し、APUの教育の恩恵を受けることが願われる。今秋のセメスターより、APUで学ぶカンボジア出身学生は4名になった。

RCAPSでは、カンボジア、ラオス、ベトナム、インドシナの国々について理解を深め、学術的関心を高めるためのセミナーを近々開催する予定である。

アジア政経学会西日本部会の開催

去る6月23日(土)、本学教室棟を会場に、2001年度アジア政経学会西日本部会大会が開催された。当日は、あいにくの天候にもかかわらず、5つの分科会全体で120名を超える参加者があり、主催者及び学会担当理事をはじめ、関係者はいたく満足している。中国問題・台湾問題・アジア全般・歴史・文学など多方面にわたる部会を中心に、合計25名の研究発表、質疑応答が活発に繰り広げられたほか、昼食後の一時間あまり、本学会前理事長で慶応義塾大学総合政策学部教授の小島朋之氏が、「東アジアと日本一地域協力の視点から一」と題した記念講演会を実施した。これには会員以外にも市民・学生など300名近い参加がみられ、「開かれた学会」の方向性を例示する恰好の素材を提供できたと考えている。なお、当日の会場運営に関して、2年生の学生が中心となって積極的かつ適切な対応がなされた。

新設大学における開催とは思われないといった内容の評価を、多くの参会者からいただいた点を特記しておきたい。



エズラ・ヴォーゲル教授来学

米国ハーバード大学名誉教授で、APUアカデミック・アドバイザーに就任いだいているエズラ・ヴォーゲル先生が9月26日、27日に来学され、RCAPS 主催の研究会を実施した。テーマは「U.S.-China-Japan Relations Since World War II」。戦後の中国の歴史的転換点に焦点をあてた米国、日本との関係の変化について報告があり、その後議論は研究会後の昼食会にも引き続き、充実した研究会にヴォーゲル先生をはじめ参加者全員が満足した様子であった。また、前日には同テーマにて学生への特別講義を実施頂いた(17カ国・地域からの総勢約60名の学生が参集)。ヴォーゲル教授の詳細な分析に学生からも大変な勢いで質問の手が上がった。学生にとり深く心に残った講義であったものと想像する。

We show that when an economy is industrializing, leisure may harm economic growth; while when the same economy has become highly industrialized, a 'proper' increase in leisure and research may benefit the national economy. Based on our theoretical insights, we show how Singapore's government has adapted its human capital policy as its economy has evolved.
The Taiwan Question and the Chinese Identity Problematic after the Cold War (Associate Professor XU Xin)	This study addresses the increased salience of the Taiwan question in China's security problematic after the Cold War. It attempts to explore how and why the politics of the China identity invoked by the new dynamics of the Taiwan question has affected China's grand strategy and regional security practice in the post Cold War era.
Chinese Society under the rule of the British 英国植民地支配における華人社会に関する研究 (Assistant Professor SEIKE Kumi)	Chinese society in Straits settlement, that is, Penang, Singapore and Maraca, is the focus of this project. I will study how the British government resolved many problems and how Chinese identified themselves under the role of the government. The colonial issue is discussed by focusing on the empirical dynamism between the ruling and the ruled.
Ecohistory and the Rise/Demise of Ancient Civilizations in Southeast Asia 東南アジア古代文明の盛衰と生態史 (Professor FUKUI Hayao)	To publish the research results of "The Dry Areas in Southeast Asia: Harsh or Benign Environment?" (granted by JSPS in 1997-1999) as Ritsumeikan Asia Pacific University, Center for Asia Pacific Studies, Research Report Series No.1.
Stable Marriage: A New Algorithm (Professor Abdullah-Al-Kafi Majumdar)	The objective of the present research is to devise a new algorithm, that takes into account the preference of the boys (or the girls) only, instead of the existing one which considers at each step, the preference of both the girls and boys at the same time. It is expected that the new algorithm would be more efficient from the computational point of view.
Compiling a bibliographical database of standard books on the Asia Pacific (Professor Paul Close)	The intention is to build a specialist database and collection of books on the Asia Pacific region for teaching and research purposes. ■Necessity of Comparative Studies on Trade Barriers between Korea and Japan

Prof. LEE Eun Sup from Pusan Univ. May 29, 2001

The advanced nations that have played a leading role in assisting Asian countries following the financial problems of 1997-1998 have shown a generous attitude to the region. This is partly because the US and and its allies wanted to ensure that their alliances, built up since the Cold War, remained robust.

Korea benefited formerly from its designation as a developing nation by being able to increase exports whilst its industries were protected at home from overseas competition through quantity restrictions and tarrifs. Korea, however, can not expect the same protection under the WTO system. Korea, as a member of the WTO, is required to ensure that domestic trade regulations conform to WTO principles.

One of those influences the WTO system has on Korea is the expansion of Korean export and deregulation of bilateral trade frictions. Another point is that the WTO requires its member nations to adjust their domestic rules and regulations to the WTO principles. It is because the member nations cannot make laws against the WTO. Therefore, Korean trade laws and customs regulations are not allowed to get out of the extent of the WTO principles. Especially, Korea that is still vulnerable in trade structure is in a difficult position to make even a step out of the WTO.

た。 途上国待遇を受けてきた韓国は、先進国から関税や数量規制などで恩恵を受け ながら輸出拡大を図ってきた。

しかし、WTO体制下では加盟国は自国の利益を追求し、韓国は今まで受けてきた恩恵を受けられなくなった。

ところが、このようなWTO体制が韓国の経済に与える長期的影響として、世界的自由貿易の発展による韓国輸出の拡大、双務的通商過程で起こりうる通商摩擦の緩和などがあげられる。またWTO体制は、韓国の法令・制度・慣習を国際基準にあわせるように要求している。というのは、WTO体制下では、原則として、WTO協定に違反した国内法は制定できないからである。

したがって、韓国の対外貿易法や関税法など貿易関連の法令は、WTOの規範から外れるわけにはいかなくなった。特に弱い貿易構造をもっている韓国としては、WTOの枠から一歩も外れることが、実質的にできなくなっている。

■ Japan's Economic Performance and Asia's Revitalization

Prof. LIM Hua Sing from Waseda Univ.

The Seminar was structured into three major parts. The first part discussed Japan's position in the Asian economic crisis; the second part discussed Japan's role in Asia's financial crisis and the effects of the new Miyazawa Plan for the economic recovery; and, the conclusion examined the role Japan could play in Asia's economic recovery.

The first part of the Seminar commented on the deficits that Asia has had accumulated during the "bubble economy" years. Japan and Asian countries face current balance deficits, international trade deficits, foreign debts, and international hedge fund speculators. In addition, economic strategies pursued by China, Japan and the United States also determined the severity of economic problems for Asian countries. The second part of the seminar discussed Japan's role in the financial crisis. Merits and challenges of the 'New Miyazawa Plan' for Asia's economic recovery were discussed by illustrating the differences in the countries of the Asia Pacific region. The speaker pointed out that even though Indonesia, the Phillippines and Malaysia show resilience in recovering in the last few years, their recovery had occurred without restructuring and reform of their economic institutions. Singapore is restructuring rapidly, while Japan is not moving fast. South Korea too is trying to implement the recommendations of the International Monetary Fund. Despite the demerits towards total recovery, the Asia Pacific region was described as having excellent fundamentals. These advantages included high savings rates by people, high investment rates, low welfare expenditures, efficient technocrats and policy makers, and human resources with high education.

The third part of the presentation examined the role that Japan could play in Asia's economic recovery. Japan has a number of advantages that it could use to make the Asia Pacific economy recover. These advantages include: high foreign currency reserves, high GDP per capita, large foreign assets, large inter regional trade surpluses and a reasonable unemployment rate. Japan's role as a major provider of Official Development Assistance (ODA) is also important. In conclusion, it was noted that Japan is like a big ship that may be able to pull the other Asian economies out of the region's economic doldrums.

セミナーは主に3部に構成されていた。最初にアジアの経済危機における日本が占める位置について、次にアジアの金融危機における日本の役割と、経済回復のための新宮沢最高の効果について、最にアジアの経済再生になけて日本が成し得る役割について論した。



第1部では、日本とアジアがバブル経済期に累積した赤字について言及した。 アジア諸国は経常収支赤字、国際貿易赤字、外債、そして国際的なヘッジファ ンド投機者などの問題を抱えている。また中国、日本、米国が追求してきた経 済戦略が更にアジア諸国の経済問題の深刻さを決定的にしている。

第2部では金融危機における日本の役割について論した。アジアの経済回復に対する新宮沢計画の長所と課題を、アジア太平洋地域諸国におけるそれぞれの状況を比較し、説明した。インドネシア、フィリピン、マレーシアではここ数年回復の兆しを見せているが、それらは経済制度の根本的な構造改革なしに起こった回復であると講演者は指摘している。日本の動きは遅いが、シンガポールでは急激に構造改革が進んでおり、韓国でも国際通貨基金の勧告を実施するよう推進している。全体的な回復に遅れはあるものの、アジア太平洋地域の経済ファンダメンタルスは良好である。このファンダメンタルスは、国民の貯蓄率の高さ、高い投資率、少ない福祉支出、優秀で効率的な専門技術者と政策決定者、そして高学歴な人的資源である。

第3部では、日本がアジアの経済回復において果たし得る役割について検討した。日本はアジア太平洋地域経済の回復を促進するのに有効な要因を多く持ち合わせている。それらとは、最も高い外貨準備、最も高い一人あたりのGDP、大きな外国資産、大きな地域間貿易余剰、相応な失業率、そして最大の海外開発援助(ODA)である。日本はさらに新宮沢計画を打ち出してきた。日本は、アジア地域の経済的停滞からアジア諸国を救い出すことができる、大きな船に擬することができる。

This survey is the earliest data available among existing governmental statistics.


